## **COURSE AIMS AND CONTENT:**

The issue of the interpretation of law for many years is of interest not only to the theory of law, but also dogmatics and the practice of law. Many issues are on the one hand very elaborated, on the other hand, they are far from conclusive.

The most important question in the issue related to the issue of interpretation and application of law is the question about the correctness of interpretation, i.e. whether there are objective rules for the interpretation. A positive answer to this question can be treated as a transcendental assumption (maximalist version: regularity as truthful) or usually relativised to consensus (correctness as predictability of the decision to apply the law). But assuming the objectivity of the procedure of knowing law seems to be the basic assumption of the vision of law in a democratic society in which the rule of law prevails.
